- 1 Bid documents including the Bill of Quantities (BoQ) can be downloaded free of cost from the e- Government Procurement (e-GP) Website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). All bid documents are to be submitted online only and in the designated cover(s)/ envelope(s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. A bid submission fee shall be remitted online during the time of bid submission.
- 2 There is no need to submit any hard copies related to this bid to the office of tender inviting authority.
- 3 The condition that the preliminary agreement needs to be prepared in stamp paper worth Rs.200 in SBD is removed. Instead, the preliminary agreement needs to be prepared in a plain paper and a scanned copy of the preliminary agreement duly filled and signed by the bidder needs only to be uploaded in the e-tenders portal while submitting the bid. The condition that the affidavit needs to be prepared in stamp paper and to be notarised is also removed. Instead, the affidavit needs to be prepared in a plain paper and a scanned copy of the affidavit duly filled and signed by the bidder needs only to be uploaded in the etenders portal while submitting the bid.
- 4 The bids shall be opened online at the office of 0 on 0 by 0 in the presence of the Bidders / their representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
- 5 More details can be obtained from the Office of 0 during working hours.
- 6 Bidders should download the BOQ , Preliminary agreement, NIT and Tender documents from e - tender website. In the downloaded item rate BOQ record the agreed rate item wise and upload the same back to the e tender site.
- 7 Rate of quantity of any item executed excess of agreed quantity will be paid such that as per the prevailing Government orders PWD Revised Manual and SBD
- 8 Original bitumen bill should be submitted on the completion of tarring works. Bill is insisted only to ensure that the Bidder has purchased bitumen. The rate of bitumen in the estimate will be paid to Bidder as per the prevailing Government orders .
- 9 No departmental supply of any materials required for the work and the Bidder should collect and use the materials for the work with his own cost and as per the directions of site Engineer in Charge.
- 10 The Tender Inviting Authority/Employer shall not be responsible for any failure, malfunction or breakdown of the electronic system while downloading or uploading the documents by the Bidder during the e-procurement process.
- 11 Details required for e-payment (Details of bank account having core banking facility and e- mail address of the bidder) shall be furnished along with the tender. Tenders not accompanied by these details will be rejected. All subsequent Government orders connected to tenders and any revision in the rates of taxes would also be applicable to this tender.
- 12 The, 0 0 reserves the right to accept or reject any or all tenders without assigning any reason thereof.
